

# Diocesan Academy Strategy Context

- 82% of secondary schools, 43% of primary schools and 47% of special schools in England are academies (as of June 2024).
- All Catholic Dioceses in England have plans in place to form Catholic Academy Trusts for all their schools to protect Catholic Education.
- There are currently 58 Academies in 9 CATs across the Diocese of Westminster, with growing engagement in all Family areas.
- All schools in the Diocese will have plans to join a CAT by 2025.

## Foreword from the Cardinal...

"Now we are living through times of considerable hardship for many ..... We have to see, be clear, and readjust. This means taking difficult decisions, marked by realism, about resources. In such circumstances it is right to look for economies that can be achieved by structures of cooperation, between schools within the same locality and within the wider family of schools. This is not an enforced 'master-plan', as you well know. It is a measured and appropriate response to the reality we face. The alternative, individual schools in isolation, will lead not only to conflict but also to the decline that eventually accompanies isolationist policies. "

#### How will we benefit?

- Economies of scale and increased resilience
- Greater collaboration
- Wider administration support
- Greater access to capital funding
- Able to reclaim VAT (on capital works)
- Recruitment and retaining the best Catholic Leaders and staff
- Protect, secure and develop Catholic Education through a network of Family CATs supporting schools



## What will not change?

- The ethos of St Catherine's Primary School
- The St Catherine's staff team
- Our St Catherine's Curriculum
- St Catherine's School Uniform
- St Catherine's Governors will still continue to serve on a Local Governing Body (Including Parent Governors)
- Our current St Catherine's Admissions Policy will continue to apply
- The timings of St Catherine's school day
- Terms and conditions of employment



## What will change?

- The legal status of St Catherine's Primary School and its governance arrangements
- The current St Catherine's Governing Body become a local governing body
- The Trust Board have strategic oversight of all Trust schools
- A CEO who leads the strategic development of the Trust
- St Catherine's School is funded directly by the Education and Skills Funding Agency (ESFA) as opposed the Local Authority



#### Governance Structure

Archbishop, Auxiliary Bishop, Vicar General or Members (5) A Diocesan Trustee, RCDOW Director of Education, RCDOW Financial Director Catholic Foundation Directors appointed on a skills basis and a Catholic Executive Officer Trust Board (8) accountable to the Board Formed from existing Governing Bodies, **Local Governing** responsible for day to day running of schools Body with Headteacher

### What are the next Steps?

Consultation period 28<sup>th</sup> April until 2<sup>nd</sup> June 2025



Results reported to School's Governing body in June



Governors to consider comments and decide whether or not to proceed

If the Governors choose to proceed we will:

- Hold a TUPE consultation with unions and staff
- Transfer land, existing SLAs and contracts to the CAT
- Introduce Trust wide Finance system
- Target Conversion date of 1st September 2025
